



Memory Care

Through focused investments in engaging environments, customized therapeutic care, caregiver education and groundbreaking technology, we will improve our patient's quality of life as well as equip caregivers throughout our community with the resources needed to care for loved ones at home.

Customized Therapeutic Programming

We use Behavior-Based Ergonomics Therapy to provide each resident with a customized treatment plan. This medication-free approach includes a library of stimulating movies, videos, games, puzzles, and custom "memory prop boxes," co-created with family members.

Expanding Caregiver Education

We have partnered with nationally recognized leader in memory care, the Hearthstone Institute, to implement the *I'm Still Here* training program. Different from other trainings, this evidence-based model encourages caregivers and instructors to work side by side, over and over, until skills are fully embedded.

Music & Memory Programs

Music is a tremendous memory stimulus, conjuring recollections of specific moments in time. We work with dementia patients and their families to identify the types of music that are most meaningful to them and build a library to share with the patient.

In fact, since the day of our founding in 1922, no Ohio Living resident has ever been asked to leave because they've run out of the resources meant to see them through.

The program that allows us to fulfill this promise is called the Life Care Commitment. Not only does Life Care assure residents that they will always have a home in our communities, it also means all residents receive the same high quality of health care and other services, regardless of their financial status. As long as personal resources are not impaired or misused, the Life Care Commitment will help assure that residents will not have to leave the campus they call home or seek another place to live.
